- (1) Terms: All accounts due in full 30 days from the original ship date.
  - a. In the event that full payment is not timely received, Buyer agrees to pay interest upon the unpaid balance at the rate of 2% per month/24% annum.
  - b. Buyer agrees to pay Seller’s attorney’s fees, court costs and expenses incurred by Seller if Buyer’s account is referred for collection or enforcement to an attorney or collection agency. Venue shall be determined in the sole discretion of seller. Buyer agrees that his credit may be limited regarding amounts and quantities of purchases without prior notice.
- (2) Buyer warrants that the above information is true and acknowledges that Seller is relying upon the representations contained herein in extending the requested credit.
  - a. All signers of this agreement, as well as guarantors under any continuing guarantee, assume joint and several liabilities for the performance of this agreement.
- (3) Buyer must raise any dispute as to billing, charges or materials within 24 hours of delivery or Buyer shall waive said dispute or problem.

**CONTINUING GUARANTEE**
